**ORDINANCE ADDRESSING FLOODPLAIN MANAGEMENT PROVISIONS OF THE
STATE CONSTRUCTION CODE**

An ordinance to designate an enforcing agency to discharge the responsibility of the Charter Township of Adrian located in Lenawee County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as Amended.

ORDAINS:

**SECTION I
AGENCY DESIGNATED**

Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of act 230, of the Public Acts of 1972, as amended the Building Official of the Charter Township of Adrian is hereby designated as the enforcing agency to discharge the responsibility of the Charter Township of Adrian under Act 230, of the Public Acts of 1972, as amended, State of Michigan. The Charter Township of Adrian assumes responsibility for the administration and enforcement of said Act through out the corporate limits of the community adopting this ordinance.

**SECTION II
CODE APPENDIX ENFORCED**

Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the Charter Township of Adrian.

**SECTION III
DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS**

Federal Emergency management Agency (FEMA) Flood Insurance Study (FIS) Entitled 26091CV000A and dated 12/12/2017 and the Flood Insurance Rate Maps (FIRMS) panel numbers of 26091CIND0A, 26091C0050D, 26091C0175D and effective 8/15/2019 are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

SECTION IV
REPEALS

All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

SECTION V
PUBLICATION

This ordinance shall be effective after legal publication and in accordance with the provisions of the Act governing same.
